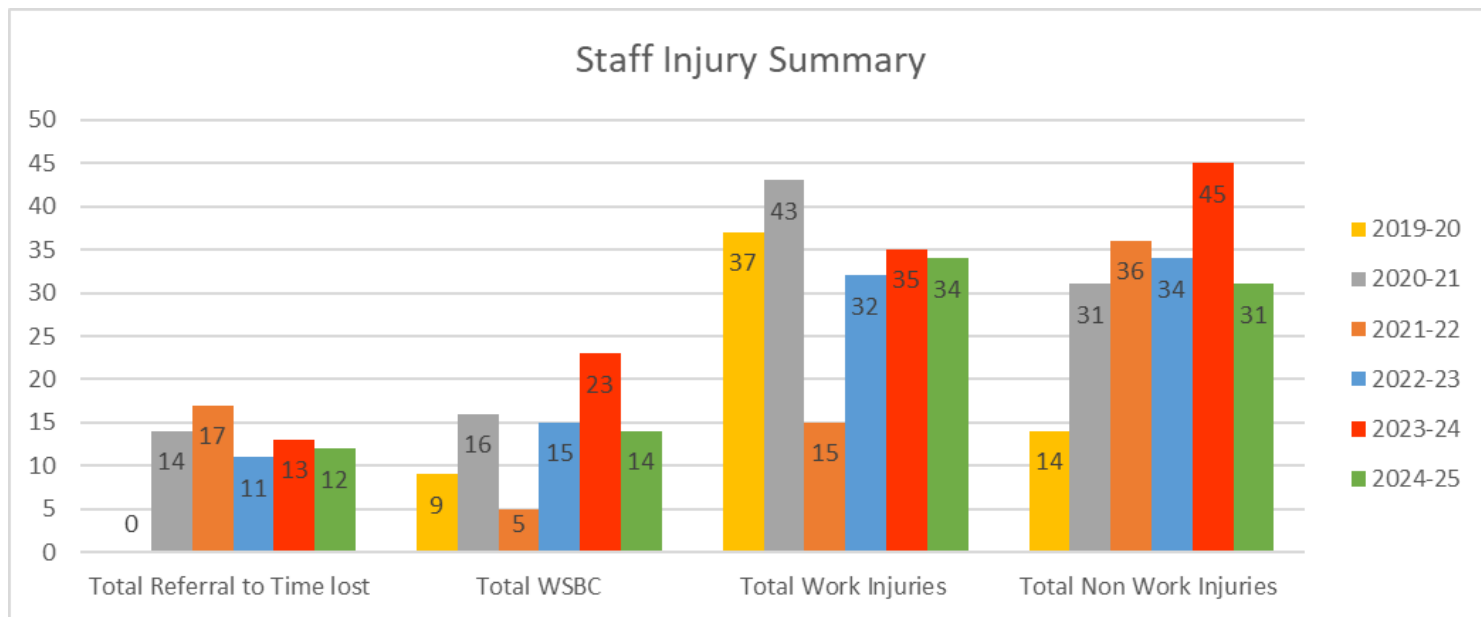
The area below keeps track of all incidents on the mountain so Whitewater understands hazards, trends, and where improvements can be made.

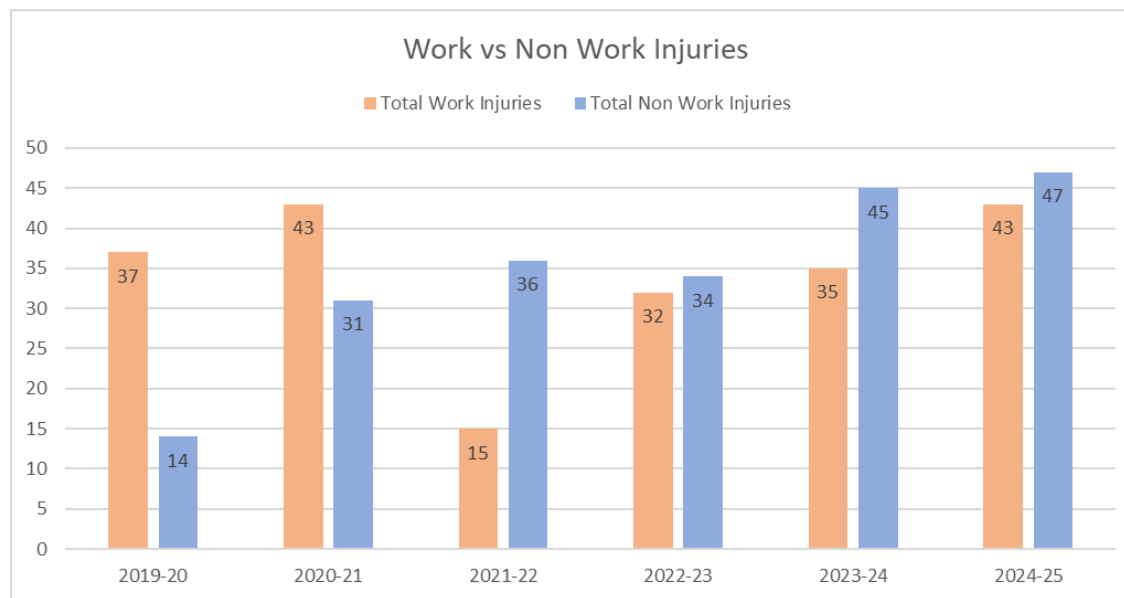
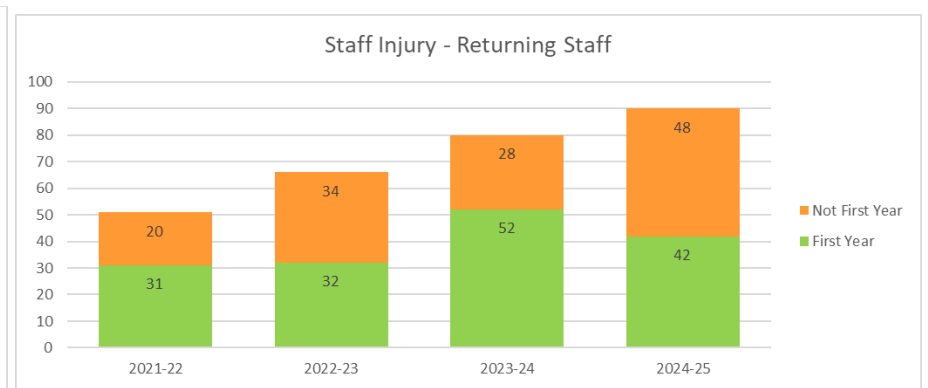
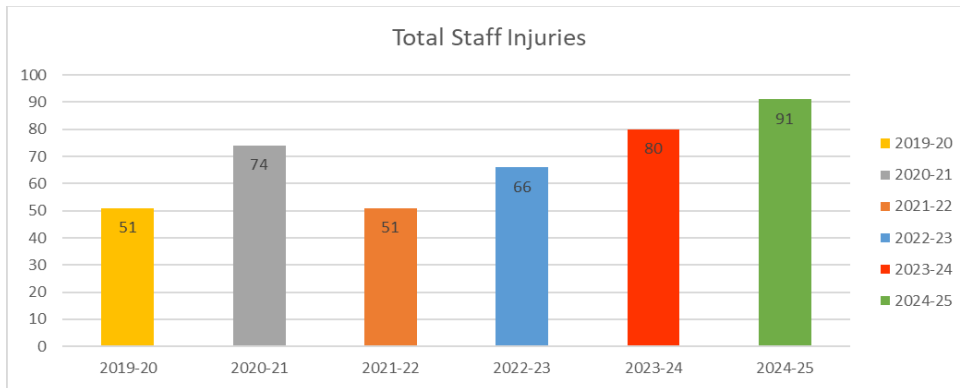
- **Near Miss/Incident Reporting:**
 - **First Aid Record-#91:** worker working on the line, awkward movement and right felt shoulder pop. Has pre-existing & ongoing issue.
 - **Corrective Action outcomes:** body awareness and job tasks.
- **First aid statistics / summary (May 1-31)**
 - Strain
- **Mechanism of Injuries**
 - Awkward twisting motion of arm positioning,

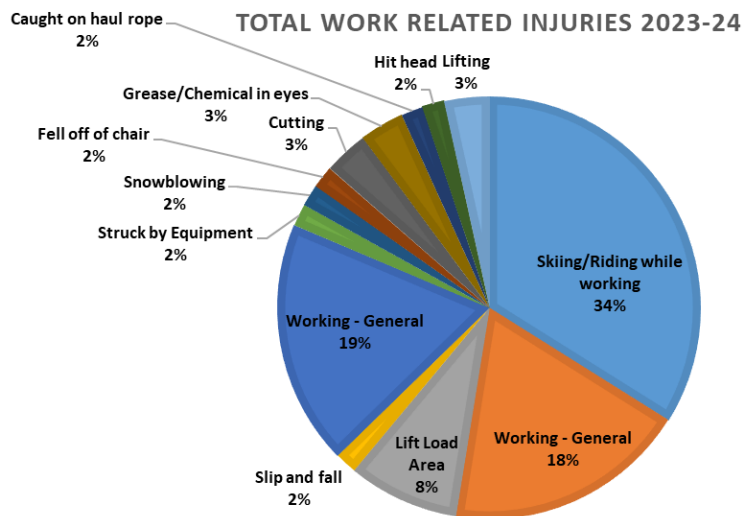
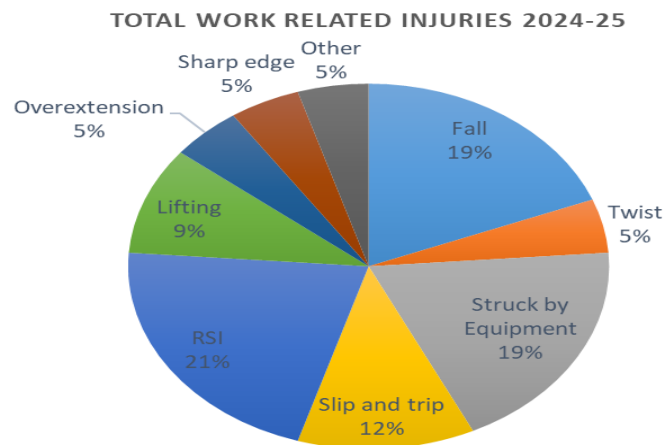

Work Related Injuries Trends

- 24/25
 - Skiing/riding in control, skiing/riding to conditions, mindfulness
 - Highest reported number of injuries (could have under reported in previous years)
 - Non-work injuries continue to grow!
 - Returning staff injuries increased
 - Mitigation:
 - Continued early season training and follow-up
 - Continued improvement of stat reporting to understand clear picture of OHS & associated injuries
 - Continued investigations into root causes
 - Employee mindfulness of work environment
