

SEASON PASS TERMS AND CONDITIONS

As a Season Passholder (hereinafter referred to as "Passholder") at Whitewater Ski Resort Ltd., I understand and hereby agree to the Season Pass Terms and Conditions of Carriage as follows:

1. All Season Pass sales are subject to the Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement (the "Release Agreement") on the reverse side. Please read the Release Agreement carefully. By signing the Release Agreement, you will waive or give up certain legal rights, including the right to sue or claim compensation following an accident.
2. All persons are required to be familiar with and obey the Alpine Responsibility Code, all signs and other notices posted within the Resort Area facilities.
3. My Season Pass, once issued, may be suspended or revoked at the sole discretion of Whitewater Management. **My Season Pass must be available for inspection at all times.** The privileges and services this Season Pass grants may be revoked in the event of misconduct, unwillingness to have my Season Pass available for inspection, entering into closed areas, including avalanche closures, unauthorized building of jumps, or failure to observe the Alpine Responsibility Code. Whitewater has the right to refuse admission to any of its service facilities.
4. The RFID card that my Season Pass is loaded to costs \$7.50. This card can be reloaded with future Season Passes or Loyalty Cards year over year. The first day I forget my Season Pass, I will be issued one (1) complimentary non-transferable Lift Ticket to ski/ride that day. For the day that this Lift Ticket is issued, my Season Pass will be blocked. If I give this Lift Ticket to anyone, I will be subject to the same penalty laid out in point #5 below. For each additional day I forget my Season Pass after the first time, or if it is lost, I will be required to pay \$7.50 for a Season Pass media replacement.
5. **Season Passes are non-transferable. I am responsible for my Season Pass. My Season Pass is solely for my own use and giving it to somebody else to use is considered theft. If someone else is caught using it, I will be liable and it will be confiscated without rebate. Those caught with fraudulent use will lose all Season Pass privileges for the remainder of the season. Whitewater may allow further use of the Season Pass with the payment of a \$500.00 penalty fee and a minimum three-week suspension. Whitewater will report the fraudulent use to the RCMP.**
6. This Season Pass is non-refundable unless I have purchased the Refund Option and I qualify for a refund under the terms of the Refund Option policy. If I did not purchase the Refund Option with my Season Pass, I understand that I have waived my right for a refund or a rollover of my Season Pass. I understand the Refund Option policy does not apply to snow conditions or any variables other than those listed in the Refund Option policy. I understand that the Refund Option is only available for me to purchase at the same time as my Season Pass.
7. If I have rented a locker for the season, I understand that **Whitewater Ski Resort Ltd. assumes no responsibility or liability for loss, theft, or damage of any kind** with respect to any equipment stored in the locker. This agreement is binding to all persons who have equipment stored therein. The agreed term of rental is for the winter operating season only. All equipment must be removed from lockers by the last day of the winter operating season.
8. I understand that age categories and cut off dates are determined as of December 1st of this season. Identification will be required for proof of age & family membership at the time of purchase.
9. I understand that there will be no compensation for any damage to clothing and equipment that occurs from the use of the Resort.
